Are there services covered before you meet your deductible?	Yes. Office visits, <u>preventive care services</u> , <u>urgent care</u> , <u>rehabilitation services</u> , <u>habilitation services</u> , outpatient mental health, outpatient substance abuse, pediatric vision services, pediatric dental exam, and <u>prescription drug</u> benefits are covered before you meet your <u>deductible</u> . <u>Copayments</u> and <u>coinsurance</u> amounts don't count toward the <u>network deductible</u> . Does this plan provide Minimum Essential Coverage? **Yes**
