Are there services covered before you meet your <u>deductible</u>?	Yes. <u>Emergency room care</u> , <u>emergency medical transportation</u> , and <u>urgent care</u> are covered before you meet your out-of- <u>network deductible</u> . <u>Copayments</u> and <u>coinsurance</u> amounts don't count toward your out-of- <u>network deductible</u> . Does this plan provide Minimum Essential Coverage? **Yes**

Minimum Essential Coverage generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.

Does this plan meet the Minimum Value Standards? **Yes**

If your plan doesn't meet the Minimum Value Standards, you may be eligible for a premium tax credit to help you pay for a plan through the Marketplace.

The Plan will not deny or limit coverage for a specific health service related to gender transition if such denial or limitation results in discriminating against a transgender individual. The Plan:
