Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care services</u> , pediatric vision services, and pediatric dental exam are covered before you meet your <u>deductible</u> . <u>Copayments</u> and <u>coinsurance</u> amounts don't count toward the <u>network deductible</u> .
